Prof. Leung is a very experienced mediator and started practising mediation since 2003. He has mediated cases of many different kinds with wide range of disputed amounts, from small commercial cases to huge land disputes involving billions of Hong Kong dollars.

He is Vice-Chairperson of the Accreditation Working Group of Hong Kong Mediation Accreditation Association Limited and a member of the Steering Committee on Mediation chaired by the Secretary for Justice.

Prof. Leung was trained in mediation firstly in the late nineties, followed by numerous other mediation related courses in the subsequent years. He is a frequent speaker and writer on mediation related topics in seminars and journals. He has assisted in HKIAC Stage 1 training courses as assistant trainer or coach on many past occasions. He has also served as assessor in HKIAC Stage 2 assessments for many times. Besides, he has on many occasions served as Lead Assessor in Stage 2 mediation assessments for HKIAC, the Law Society of Hong Kong and Hong Kong Mediation Accreditation Association Limited.

Mr. Chung has been practising mainly in the areas of civil litigation and arbitration. While his practice covers a broad spectrum of areas in civil matters, he is specializing in arbitration and construction disputes. Apart from representing his clients in litigation, arbitration and Appeal Board (Buildings) hearings, Mr. Chung is often appointed as an arbitrator in matters of construction disputes, international trade and commercial disputes. He was also appointed as the Hon. Secretary (2009-2011) and the Vice President (2011-2012) of the Hong Kong Institute of Arbitrators.

Mr. Chung's practice also extends to mediation. He is listed on the panel of mediators of a number of local and overseas professional institutes. He has conducted mediation for various kinds of disputes in the areas of construction contracts, commercial contracts, probate, land, property management, negligence claims and shareholders/partnership disputes. He was one of the task force members in setting up the Joint Mediation Helpline Office Limited (JMHO) and a director of JMHO from 2011-2012.

Mr. Chung is an External Consultant (Law Training) of the CityU Professional Services Limited and also a Visiting Law Lecturer of the Hong Kong Polytechnic University.
